

Website Privacy Policy

Please read this privacy notice carefully as it contains important information on who we are, how and why we collect, store, use, and share personal information, your rights in relation to your personal information and on how to contact us and supervisory authorities in the event you have a complaint.

1. Who We Are

2. Children's Online Privacy Protection Act

We will hold all client and customer personal data in our files for six years, or until you are no longer a client or customer, whichever occurs last.

g. Reasons We Can Collect and Use Your Personal Information

4. Use and Transfer of Your Information Out of the EEA, UK
